President, Dr.Himanshu Aeran welcomed the members and called the meeting to order. He added that as per the new AGM protocol followed since the AGM at Ahmedabad, we will take up only the election agendas now & the remaining agendas would be taken up at 5.30pm. Members could vote from 11am to 3pm at a designated place. The identity of members would be verified prior to voting. The results along with the rest of the agendas would be taken up at 5.30pm. He requested Dr. V.Rangarajan, Secretary-cum-treasurer, to proceed with the agendas.

**Agenda No.5** - To elect two (2) Vice-Presidents of the Society to hold office for a term of one (1) year

**Agenda No.6** -To elect fifteen (15) Members to the Executive Council of the Society to hold office for a term of two (2) years

Secretary-cum-treasurer Dr.V.Rangarajan announced that for the post of President-Elect there was only one nomination – Dr.KR Kashinath, and it was in order.

1. Indian Prosthodontic Society is a registered Society and has obtained registration u/s 12AA of the Income Tax Act with effect from 1<sup>st</sup> April, 2015 (Sl. No. 0237) vide UR No. AAAAI3797H/05/15-16/T-0237 dated 26<sup>th</sup> Nov, 2015.
2. The Society's headquarters is in Chennai and during the year under review, the following branches of the Society were also functioning : Andhra Pradesh, Bengaluru, Chattisgarh, Uttar Pradesh, Gujarat, Jaipur, Karnataka, Kerala, Odisha, Nagpur, Bhopal, Mumbai & Pune.
3. In the case of some branches, bank statements as at the end of the accounting period have not been furnished and hence the reconciliation with bank accounts are pending.
4. The audited financials received from Chattisgarh, Uttar Pradesh, Gujarat & Jaipur all of which have been integrated in the Society's financials.
5. The Head Office of the Society has not received complete accounts or full clarifications from some of the branches and the consolidation of figures has been done only on the basis of incomplete information and to that extent the figures are subject to changes.
6. The surplus of 44<sup>th</sup> IPS Conference at Mumbai and 18<sup>th</sup> PG convention have been accounted at actuals, on the basis of accounts submitted by the respective branches.
7. Membership Fees are accounted on Receipt basis.
8. Royalty Income dues from Walter & Kluwer and Sponsorship Income from Springer India have been accounted on accrual basis, as the relevant amounts have been subsequently received during the following financial year.
9. Service tax liability on membership fee has been duly discharged for the Financial Year.
10. The financials appended are provisional and are subject to audit as mandated by Income Tax Act and only after completion of the verification of financials and further clarifications from branches, the final audit report will be issued and then the income tax returns will be submitted to the authorities.
11. The amounts are rounded off to the nearest rupee.

## Executive Council's Report

It's a pleasure & privilege to present the report of the Executive Council of the Society for the year 2016-17. The EC met 3 times during the year at Bengaluru, Rishikesh & Hyderabad.

Promotion & creating awareness of the specialty among the general public has been the objective with which '**Prosthodontist Day**' was launched on January 22<sup>nd</sup> this year & it will continue to be an annual feature. We are thankful to Members, Faculty, Students, Colleges, Regional Branches for their wholehearted participation and coming out with innovative programs to enhance public awareness of our specialty. A movie to create awareness about the specialty was launched during our 44<sup>th</sup> National conference at Mumbai last year.

September 18<sup>th</sup> 2016 was a historic day for the Society. We became the first dental society in the country to inaugurate our own **permanent office in Hyderabad**. We have now started functioning from the office & do plan to commence continuing education programs on a regular basis for the benefit of members. On September 10<sup>th</sup> this year, we launched our **mobile app** for the society, which will further ease communication. It can be downloaded on play store & app store by searching for ips online.

One of the unique programs of our Society is our **International Scientific Exchange with the Japan Prosthodontic Society**. This year also 6 young prosthodontic members of our Society have been selected to undergo specialized training in various universities in Japan. They are Dr. Varuni Arora, Dr. Ridhima Gupta, Dr. Bhasker Agarwal, Dr. Pranjal Radke, Dr. Umesh Pai, Dr. Deenadayalan Lingeshwar. On behalf of all the members, we wish them the very best in their advanced education. This is the 9<sup>th</sup> year of this first of its kind collaboration between an Indian dental specialty organization & the Japan prosthodontic society.

Last year we announced that **the biennial conference of the ISMR** (International Society for Maxillofacial Rehabilitation), will be hosted for the first time in India in the 2020 by the Society. The Presidents of both societies signed an MOU to kick start the process, during the national conference in Mumbai. This should give a huge fillip to maxillofacial prosthodontics in the country and affirm the growing stature of our Society internationally.

**The Journal of Indian Prosthodontic Society (JIPS)** had a steady progress this year. It has obtained Scimago Journal & Country Rank (SJR) ranking of 0.201 (Q 3) compared to 0.164 (Q3) positioning last year. The listing rates JIPS at 11 against 17 (last year) among all dental journals of Asiatic region and one among the top 5 dental journals in the country. It has been recognized as the top prosthodontic journal in our country. We are in process of getting indexing from a few more agencies for wider acceptance by the global scientific community. To make a more significant impact, we require more support from our members. We request all members to cite JIPS in all their publications.



The Journal has 131 subscribers in addition to the life members of the society. The head office on average prints 2500+ journal copies, which is the largest number of prints made by any specialist dental society. The journal soft copies inclusive of archives have been updated in our website. It is available both in IPS app and IPS website. Additionally, the journal is available in journal website and Pubmed central. The total number of articles submitted for the year 2017 (till sept 15,2017) is 240. The Journal has an acceptance rate of 10 % for the year 2017 compared to 8% for the year 2016. The response to authors on the submitted manuscript has been standardized. An average two-month response time (accepted standards) is now established for first submission and one month for revision submissions. The editorial board conducted a pre conference work shop on manuscript writing for the benefit of postgraduate students at the 19<sup>th</sup> IPS PG Convention, Rishikesh. The course was well designed highly appreciated by the students. The database of members address for journal shall be updated as a regular calendar event. It will be on 31 January and 31 July every year. New members joining in the middle shall be added according to this calendar event for their journal hard copies. The members are requested to update their records in head office databases for effective communications. We thank the Editor Dr. Gopichander, Editor Emeritus Dr. Suhasini Nagda & Past editors Dr. Ravindra Savadi & Dr. Shilpa Shetty and the entire Editorial board & reviewers for their immense contribution towards the development of our Journal.

**Community outreach program** is the society's endeavor to educate the general public & provide free treatment to needy. Department of Prosthodontics, GDC Bangalore, under the guidance of Dean Dr. Prithviraj conducted a mega free Denture Camp at Sharavana balagola on 17 & 18 December where over 140 Completed Dentures were delivered to poor patients. Dr J R Patel, Dean, Nutan Dental College, Visnagar has tied up with a Shri Baldevdas Charitable Trust's Manav Parivaar, Matar, Gujarat which organises camps on a regular basis. So every 3 months they conduct free denture camps & have now delivered more than 250 dentures. Dr Sunil Dhaded, Professor & Head, AME's Dental College, Raichur, conducted a denture camp April 2017 at Devadurga and provided 60 complete dentures and 24 partial dentures in 2 two days and one more single day denture camp at Adoni with Lions club and delivered 15 CDs and 14 PDs. These camps are partly sponsored by the society. We encourage more members to organize such socially useful outreach programs.

After the tremendous response from members last year, this year also on October 1<sup>st</sup> "**International Day of Older Persons**", in order to recognize the important contributions that older people make to our world, while raising awareness towards issues of ageing this year, members in Regional branches & various dental colleges in the country will organize free Denture Camps & programs for the benefit of the elderly people.

The **State/Regional branches** have now commenced all over the country. They pave the way for spreading the awareness of the specialty to the entire country. We now have 17 branches. They all conducted CDE programs and participated in all outreach programs of the Society. We encourage all members to also become members of their respective regional branches.

The **Indian Board of Prosthodontics** is a premier flagship program of the Society to identify "Prosthodontists par excellence" in the country, through a countrywide exam conducted for the members of the IPS. The exam is conducted over two parts. The first one being a theory part and the second part being an intense evaluation of specified cases and a in-depth Viva.

Instituted in 2012, the first Diplomates were awarded last year out of a total of 5 candidates who were eligible to take up the Par II exam. They were Dr. MohitKheur and Dr. AnandKrishna G.N.

This year, two candidates will appear for the Part II. We would like to use this platform to once again invite all prosthodontists who have a great academic and clinical record to take up this exam and make their name not only in the IPS but also in their respective practices. We thank the IBP Chairman Dr.Padmanabhan & Secretary Dr.RavindraSavadi and all the board members for their stellar effort in putting together this prestigious program.

The **Council for Posthodontic Research** (CPR) was formed last year to promote research among its members. The council proposes to invite research proposal from IPS members and member groups and grant funding for chosen projects. Two protocol finalization meetings have been conducted for the first project " Toxicology of plural derived mesenchymal stem cells" and all the teams granted the project were informed to initiate the research and submit the progress. We are in the process of gathering support from other companies like Colgate, Nobel biocare, and Bredent to support our research projects. T-scan has come forward to support research on Occlusion and Digitization. We thank the Council Chairman Dr.Mahendranadh Reddy, Secretary Dr.Mahadevshastry& other members involved for their efforts in this endeavor.

The **19<sup>th</sup> PG convention** was organized in June 2017 by Seema Dental College, Rishikesh. There were over 1300 registrations for the convention. There were 23 pre conference courses, which attracted 700 registrations, 345 Oral paper presentations, 170 poster presentations and 91 table clinic presentations by PG students. There were also more than 7 gurukul sessions and 20 one-on-one sessions conducted by faculty.

Key-note lectures were presented by Dr.MaheshVerma, Dr.ManuRathee, Dr.Anandkrishna, Dr.SanjayKalra & Dr.SaloniMistry apart from the prestigious Dr.Udani Oration by Dr.ChetanHegde. A quiz was conducted by Dr.UV Gandhi &Dr.NeetaPasricha. On behalf of the society, we would like to thank the entire organizing committee headed by Chairman & our Immediate Past President Dr.HimanshuAeran Organising Secretary-cum treasurer Dr.Varun, Joint Secretary Dr.GaganSharna & Scientific Convener Dr.Jyotsana and all the faculty & students of this esteemed institution for their wholehearted commitment & untiring effort in putting together this awesome conference. We would also like to express our deep sense of gratitude to the management of the institution for their unstinted support & cooperation and throwing open the doors of their reputed premises to the PG students & faculty of the entire country.
