# 49th IPS National Conference, Chennai.

49th IPS National Conference was held in Phygital mode (Physical and digital) at Chennai, 1<sup>st</sup>to 5<sup>th</sup> December2022.235 competitive student papers, 70 non-competitive student papers, 108 keynote lectures, many symposiums and 8 Young star speakers comprised the scientific deliberations of the conference. Dr.SudhaSeshayyan, V.C. of the most esteemed government university- The TamilnaduDr.MGR Medical University was the Chief guest for the inauguration. Dr. V. Rangarajan delivered the prestigious BC Shroff Oration. Apart from the virtual lectures, physical lectures were also arranged. Given the importance and significance of the conference an enthusiastic team of eminent local and national prosthodontists are coordinating the mega event. It will be an amalgamation of excellent scientific content and wonderful Golden Jubilee celebrations. A plethora of national & international speakers have already confirmed their participation. The BC Shroff Oration will be delivered by international acclaimed teacher and Prosthodontist Dr. Gary Goldstein. The Golden Jubilee Oration will be delivered by Dr. Shankar Iyer. More than 40 Pre-conference courses are also being planned. Continuing the momentum of the Golden Jubilee celebrations, cultural programsi.e., a live







singer, fusion dance and bollywood night are being planned during the conference. The "IPS life time achievement award" will be presented to Dr. Hari Prakash - Past President and Secretary - IPS and veteran in the field, an astute teacher and academician, who has contributed immensely to the growth of our society and specialty.

## 24th IPS PG Convention

The 24th IPS PG Convention, 2022 was hosted by the SDM College of Dental Sciences and Hospital, Dharwad in physical mode. Flawless series of events were conducted in spite of many hurdles considering concerns for COVID-19. There were a total of 1772 registrations with 1300 students. Inauguration of the convention was graced by Chief Guest, Shri Prahlad Joshi, Ministry of Parliamentary Affairs, Coal and Mines of India; Guest of Honour, Prof.Seshu, Director, IIT Dharwad; Prof.Dr.Niranjan Kumar, Vice-Chancellor; Dr.Balaram Naik, Principal, SDMCDSH and the IPS, head office President, Vice Presidents, Secretary, Treasurer & Editor. The Dr TM Udani Oration was delivered by Dr Akshay Bhaghava Immediate Past President of IPS followed by fifteen keynote lectures by eminent teachers and prosthodontists. 26 Pre Conference Courses were mentored by 71 experts in the field and were successfully conducted, for which over 1300 students participated. The scientific sessions included 357 paper presentations, 312 posters, and 90 table clinics in total; which were judged by more than 200 chairpersons. A separate session was conducted for the prestigious Dr. EGR Solomon award for the 2 best scientific papers under the original research category.Dr. Suguna Priya. G, Rajarajeswari Dental College and Hospital, Bangalore and Dr. Nupur Trivedi, Narsinhbhai Patel dental college were the awardees for the same. Concurrently, Guru bodhane was held where 20 mentors had a one-on-one interaction with over 150 students. Apart from scientific sessions, a cultural event - Voice of Prosthodontics was conducted in the evening, for which 20 students participated and competed for first place. A peppy Prosthodontics Fun Quiz was also conducted, in which 40 students participated. A Mega trade exhibition was arranged where 20 dental-associated companies set up stalls. A lavish gala banquet dinner was arranged for the delegates and students at Ambarai Gardens, Dharwad. The convention concluded with the valedictory function and the distribution of certificates to all the delegates and participants. The Journal Publishers office has been shifted from Delhi to Chennai IPS regional branch journals are also striving for procurement of ISSN and D.O.I. Utilization of external agency for evaluation of statistical analysis for manuscripts being submitted to the journal is being carried out. A token amount as publication charges Rs 5000 for IPS Members, Rs 10,000 for Non-members and Dollars 200 for manuscripts being submitted by foreign authors is being charged for publication. Golden Jubilee Reviewer's meet 2022, a Reviewer's Workshop was organized in a flawless manner at Mrugavani Resort, Hyderabad On 16th and 17<sup>th</sup> of September 2022. The program was highly successful, very useful and the need of the hour in order to improve the standards of our national journal. For the training and development of our reviewers, who are the mouthpiece of our national journal, IPS has sponsored half of the total expense, an amount of approximately Rupees Five Lakhs.50th IPS Conference proceedings are also planned to be published as a Supplementary copy in the National Journal, which shall include abstracts of scientific presentations, papers, and posters.







#### **Indian Board of Prosthodontists**

AGM for IBP was held online on 22<sup>nd</sup> May 2022.Dr.Sendhilnathan, as Secretary, IBP and Dr.Sabarinathan were inducted as new members of the board.As per feedback received from candidates appearing for the IBP examinations as well as those who have already passed the examination, the examination format HAS BEEN streamlined with a modification in the total number of clinical case submissions under different criteria. The candidate undergoing the part II examination currently needs to submit 2 clinical cases in each of the 4 categories, which amounts to a total of 8 case submissions.Part-I Examination (Summer) was conducted Online in April 2022 simultaneously at six centers throughout the country. Ten candidates appeared for the examination and three candidates have come out with flying colors.A workshop was also conducted on 31<sup>st</sup> July for candidates having passed the Part I examination to provide orientation for the Part II examination. The orientation program for Part-I Examination was held Online on 7<sup>th</sup> August 2022 along with the orientation program for Part II Examinations on 8<sup>th</sup> August 2022. This year, 9 candidates plan to appear for the Part-II Examination, planned to be held at IPS H.O. on 14th and 15th of October, 2022. The Part-I Examination has been planned to be held on November 6th, 2022.

# Council of prosthodonticResearch(CPR)

Dr. K. Mahendranadh Reddy, Chairman, CPR had conducted a series of meetings with Dr.Mahadev Shastry, Secretary, and CPR council members present in India and abroad. Final key points regarding how to streamline research grants and the format of applications are in the final stages of finalization. The whole idea of the board is to support original research. IPS Head office has promised financial aid to be given per year to deserving projects. Financial aid will be disbursed to those deserving research projects that will be approved and selected from the proposals expected to be submitted to the Council.

# Treasurer's report

The mandatory filing of GST returns on monthly basis is being done on a regular basiswith cooperation from most of the regional branches.Dr.K.Sanketh Reddy, the Treasurer, conducted three online orientation programs for all regional branch treasurers with all the office bearers of IPS regional branchesfor smooth coordination of various activities involving financial transactions. An app has also been launched in order to streamline the entire process of account submission with options of instantaneous; multiple uploads of bills, vouchers, and invoices. New student memberships are also now available online.







# **Community outreach programs**

Various Community outreach programs were conducted throughout the country. In the month of January, the One Day Denture Camp was conducted by the Department of Prosthodontics, Government Dental College and Hospital, Ahmedabad, Gujarat. Complete dentures were delivered on the same day with all clinical steps. All the patients were also given Denture maintenance kits free of cost along with meals and refreshments. Mar Baselious Dental College, Kothamangalam, Kerala in association with IPS Kerala State Branch had completed its 1st phase of the IPS community outreach program on the 25th of February. The first phase delivered 25 dentures to the poor and needy of society. A few other Community outreach programs were also conducted in Karnataka. The guidelines regarding the funding of Community outreach programs and the format for the application form are finalized and will be circulated soon. The organization of community outreach programs is being done outside the confines of educational institutions and hospitals for better reach. At the same time, ourprograms are being planned in different remote locations for the benefit of a wider range of the population.

# **Continuing education programs**

The most awaited IPS Masterclass Workshop 2.0 FMR (Full Mouth Rehabilitation) physical workshop was held on 16th & 17th April, 2022 at IPS Head office, Hyderabad. Dr. K. Mahendranadh Reddy &Dr.Chethan Hegde were the mentors for the program and participants from different parts of the country attended the same.A Clinical National Masterclass on Biofunctional Prosthetic System (BPS) was organized at the IPS Head office, Hyderabad on 23rd and 24th July 2022. It was a two-day intense training workshop including lectures, lab, and clinical demonstrations with live patients. Another 2-day intensive Master Clinician program on Maxillofacial Rehabilitation was conducted on the 8th and 9th October 2022 at IPS Head Office. For the first time on one platform, an Oculoplastic Surgeon and a Maxillofacial Prosthodontist together provided training on ocular prosthetics. Two days of an intensive training program with a Demonstration on Live Patient & Hands-On training session on models was planned and executed. For IPS students and life members, free registrations were also made available for the Ivoclar e. max Press summit 2022, Global Kols session online on 28th and 29th September, where nine international speakers shared their knowledge on pressable ceramics. The link for the free registration was sent to all the members requesting everyone to take advantage of this opportunity.







# IPS Certificate course in Health professions education:

This Certificate course for dental educationists, an informative and very useful programwas conceptualizedand conducted by Dr Suhasini Nagda, Past President, IPS under the aegis of IPS (Academic excellence program). The first batch with total strength of 35 participants all over India was started under able leadership and excellent vision of Dr.Suhasini Nagda in 2021. The program is specifically designed for the dental educators having excellent nationally renowned faculties and spread over the span of 12 months with four modules followed by educational projects. The modules comprise of leadership, teaching and learning methodology, curriculum designing and implementation, assessment and all the participants having their own LMS. The ongoing competency-based learning management system "course" has been customized for the Indian Prosthodontic Society.70 sessions have been conducted. 31 Educational research projects by the members enrolled for the program have been completed by the participants in their parent institutions and the implementations of these projects are underway. The ceremony of certification is planned at the 50th IPS Golden Jubilee conference. The next batch of participants for the certificate course will commence in January 2023.

#### Formation of New Committees -

Sub-committees (2021-22) were formed to involve all EC members and distribute the working structure and load of the Society. These committees have contributed to the efficient and result oriented functioning of the society. The formation of these committees helped in better communication of information and setting the strategic direction ensuring effective management of various programs. The following are the IPS Sub-committees for the year 2021-22:1. Public awareness committee. 2. Ethics and disciplinary committee. 3. Community out-reach program. 4. Awards committee. 5. Continuing education council. 6. Finance and audit. 7. Website and IPS app development committee. 8. Student membership upgrade. 9. Regional branch liaison committee. 10. National student exchange programme. 11. Member benefit programs (Insurance). 12. IPS times. 13. Merchandising committee and 14. Constitution committee. All the committees have proposed policies and recommended actions under their jurisdictions, subject to final approval by Executive Council. All the members have been proactive and contributed to the purpose and objectives of their respective committees. The progress reports for all the committees were presented during E.C. meetings.

The continuous efforts of all the new sub-committees (2021-22) for the better functioning of society are highly appreciated. During this golden jubilee year of the Indian Prosthodontic







Society, it is planned to convert the membership status of all the postgraduate students to Life members. A target is 100% membership upgrade from Student Member to Life member during the present year has been set. A special membership drive with a target of 100% membership upgrade from Student Member to Life member during this golden jubilee year of the Indian Prosthodontic Society is being conducted. The efforts are alsoongoing to revamp the website and templates have been prepared for various interphase. IPS app is being upgraded for better utilization and functioning. The recommendations and guidelines about the awards to be constituted under the banner of IPS have been finalized and circulated. Many progressive changes with upgradation are being planned and will be implemented in near future. The proposed affiliations, exchange programs, MOUs, and association with various international Prosthodontic societies are planned and we hope for some positive outcomes very soon.

# **IPS Indemnity Scheme**

The IPS Indemnity Scheme has been continued in the current year also for IPS members, although many other associations/societies i.e. dermatology and preventive medicine had to discontinue the same. The renewal fee (750+ GST) is the same as last year with a 75% discount in base premium rates being offered directly (3400+ Tax). 111 people availed advantage of this opportunity last year, and most of them have continued their insurance in the current year also by paying the same premium. Emphasis on the wider promotion of the scheme has been put and many members are taking advantage of it. Updated renewal and new policy registrations under the IPS Indemnity Scheme are available on the website. Awareness about the scheme is being spread using promotional templates. 122 new policy registrations have been reported under the IPS Indemnity Scheme. To simplify the process of registration, the contact numbers of concerned insurance personnel have also been added to the concerned page on the website.

# **Regional branches**

The office bearers of almost all the state branches have submitted the necessary documents about the AGMs and annual accounts. All the regional branch's office bearers were requested to conduct IPS Regional branch AGM on or before 15th May 2022 and to ensure that a copy of the AGM notice was forwarded to IPS Secretary. All the IPS regional Branch secretaries were also requested to forward details of various nominations received along with the supporting documents to the IPS Secretary and to make sure that the constitutional requirements were strictly fulfilled during the process of conducting the AGM and election of IPS regional branches

PRE-CLINICAL PROSTHO-STAR (UG 2nd Year) for students who have scored 1st Mark in the subjects of Dental Materials and Preclinical Prosthodontics at the University exams conducted every academic year, PROMISING PROSTHO-STAR (UG Final Year) for students who scored 1st Mark in the subject of Prosthodontics and crown & Bridge at the University exams conducted every academic year were the categories for undergraduate students. BUDDING PROSTHO-STAR award was given in the PG-student category. For OL members, PROSTHO-STAR for members not more than five years after completion of MDS, PROSTHO WIZARD for members completed five years and not more than 10 years after MDS, PROSTHO MAESTRO for members completed more than 10 years after post-graduation and EXCEPTIONAL PROSTHO-CLINICIAN was given. The EC of the regional branches appointed a scrutinizing committee and decided the winners. We congratulate all the winners and participants of these awards.
